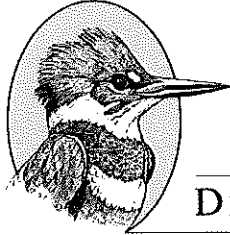

Dear Examiners Mullany and O'Connell:

Our organization has received three reports from Dr. Tricia Miller funded by intervenor funding in the above referenced proceeding. We provided these reports to the applicant on April 5, 2019 for their review for potential privileged information.

On April 8, 2019, the applicant advised us that they believed two of the reports should be submitted under confidential cover in their entirety. We do not agree with this determination.

We have sought clarification from the applicant for their determination, but have not received a reply.

According to the Protective Order issued October 24, 2018 in this proceeding, in order to qualify materials as Protected Materials, a Request for Protected Status must be submitted to the Presiding Examiners and served on all parties. To date, we are not aware of any such request on the part of the applicant or any other party.

We believe these reports need to be part of the record in this proceeding in timely fashion, therefore, it is our intention to submit these reports to the Secretary of the Siting Board and distribute to the parties on April 18, 2019.

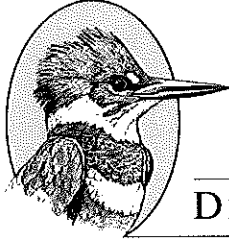
