Section 1. The said year <u>2022 Recommended Final Budget</u> of the Town of Windsor submitted, approved, and filed, as aforesaid, be and the same is hereby adopted and established as the year <u>2022 Annual Budget</u> for the Town of Windsor for the fiscal year beginning <u>January 1, 2022</u>. Said annual budget as so adopted and established shall be entered in detail in the minutes of the proceedings of the Town Board.

Section 2. The Town Clerk of the Town shall prepare and certify, as provided by law, duplicate copies of the said Town annual budget hereby adopted and established, and shall deliver one of such copies to the Supervisor of the Town; and the said Supervisor of the Town shall present such copy to the Board of Legislators of the County of Broome as required by law.

Section 3. This resolution shall take effect immediately.
